

Putha Uttarganga Rural Municipality, Office of the Rural Municipal Executive invites sealed Quotation from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and

Qualification Criteria are provided in Section III of the Bid Documents.

The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years and enlisted by DoLl are eligible for bidding. New fabricators may apply in joint venture with an eligible firm having the required experience.

4. Eligible Bidders may obtain further information and inspect the bidding documents at the Putha Uttarganga Rural Municipality, Office of the Rural municipal Executive

5. Bidding documents may be purchased from the office of the Rural Municipal Executive by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee of Rs. 1000.00 (one thousand only) for bid documents as mentioned in the following table, until 2077-10-07 BS (20-01-2021).

6. Bids must be submitted to Putha Uttarganga Rural Municipality, Office of the Rural municipal Executive, on or before 12:00 **noon** on 2077-10-08 BS (21-01-2021). Documents received after this deadline shall not be accepted.

Bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2077-10-08 BS (21-01-2021AD.) at the office of Putha Uttarganga Rural Municipality, Office of the Rural Municipal Executive. Takasera, Rukum, East. Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security in bank guarantee issued by the A class commercial bank licensed by Nepal Rastra Bank.

8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
